ENROLLMENT FORM**

The Palo Verde Unified School District is pleased to announce that its 2023 Expanded Learning Opportunities Summer Rec Center Program is open for enrollment. Interested parents/guardians should review the information below and fill out the Enrollment Form to enroll your student in the Rec Center Program offered by the City of Blythe in partnership with PVUSD. Should you have any questions regarding the Rec Center Program or the Enrollment Form or require assistance, you may contact the summer school principal at (760) 922-7174. Completed Enrollment Forms should be returned to Felix J Appleby School no later than 12:00 pm on July 5, 2023.

What? The Program is a result of a collaboration between the District and the City of Blythe that offers an afternoon session of recreational time overseen by the City. This is an optional program and students must be enrolled in and attending the 2023 elementary summer school program in order to participate in the afternoon Rec Center Program.

Who? Enrollment in the Program is limited to District students who are enrolled in and attending the elementary summer school program and is entirely voluntary and at the discretion of each student’s parent/guardian.

When? The Program begins on June 20, 2023, and ends on July 19, 2023. However, students may enroll as late as July 5, 2023. Enrollment Forms must be completed prior to participation in the Program.

The Rec Center Program will take place from 12:15 p.m. to 5:00 p.m. and will be managed by the City’s Program Coordinator. The Program will take place Monday-Friday, except holidays.

Where? The afternoon session of recreational time overseen by the City will take place at Joe Wine Blythe Recreation Center, located at 127 S. Main St., Blythe, CA.

Students enrolled in the Rec Center Program will be transported by the District from the Elementary Summer School Location, Felix J. Appleby, to the Recreation Center. Under no circumstances are minors permitted at the Recreation Center after 5:00 p.m. without a parent or guardian. As such, students enrolled in the afternoon portion of the Program must be picked up from the Recreation Center by a parent, guardian, caregiver, or District transportation at 5:00 p.m. Parents/Guardians are encouraged to pick up their child from the recreation center.
